CORONA INCONSISTENCIES FOR THOUGHT

When statements, actions and measures during the Corona pandemic are examined in more detail, a number of questions arise that make one think ...

AT THE BEGINNING OF THE PANDEMIC

- 1. Why was a council of experts consisting of 20 to 30 virologists, infection epidemiologists and microbiologists not immediately formed at the beginning of a worldwide threatening pandemic in Germany, but only Mr Drosten was trusted as an expert, who was already wrong with his views in the bird and swine flu cases?
- 2. Why was an autopsy ban ordered at the beginning of the "worst pandemic ever" rolling towards us?
- 3. Why has neither the state nor the RKI shown any interest in carrying out intensive research and reappraisal in the first hotspot to appear in Germany (Heinsberg)?

PANDEMIE

- 4. Why was no distinction ever made between those who died "of" and "with" Corona? Wouldn't that have been a decisive characteristic for the severity of the so-called pandemic?
- 5. Where does the evidence-based knowledge come from that a PCR test could indicate corona infection?
- 6. How can it be that since the beginning of the pandemic, trust has been placed in a test procedure (PCR test) which the inventor himself says is not suitable for diagnostic purposes and also cannot distinguish between COVID19 viruses and other viruses?
- 7. Why was it tolerated or demanded in the laboratory-technical evaluation procedure of the PCR tests that these tests are carried out with CT values of clearly more than 30, although above 24 no infectivity can be assumed and thus false positive results are knowingly brought about?
- 8. Why has an epidemic situation of national importance been maintained in Germany for 18 months, although the lethality (lethality) of Covid19 is around 0.2%, and for those under 70 years of age it is as low as 0.04% (similar to that of an average influenza wave)?
- 9. Why has there been no influenza (flu) since the start of the Corona pandemic, even in countries without measures?

- 10. How can it be that healthy and symptomless people are discriminated against and are supposed to be a danger?
- 11. Why has the number of deaths only increased since vaccination began and not since the beginning of the "pandemic"?
- 12. How can it be that no one in the world has yet succeeded in isolating the SarsCov2 virus and thus proving its existence?
- 13. Why did the pandemic not strike mercilessly and cause excess mortality in countries that took little or no action?
- 14. Why does the (official) data show on closer inspection that there was never a pandemic and yet it is still frantically clung to in Germany to this day?

policy and action

- 15. Why have politicians and the media never pointed out that the most effective protection against viruses is an intact immune system?
- 16. Why is it that politicians and the media ALWAYS start spreading FEAR about all new developments in the Corona crisis before analyses and expert opinions are available, and even though it has already been shown X times that the exaggerated fear-mongering later proved to be unfounded?
- 17. Why are the drastic measures in Germany not evaluated and scrutinized for their effect (especially in view of developments in many other countries)?
- 18. Why are no conclusions drawn from the finding that major events (e.g. demonstrations or football matches such as the European Championship in the summer) have not contributed to any significant incidence of infection?
- 19. Why do we continue to insist on masks and distance rules, even though several large-scale studies (including one with over 1 million Chinese) have shown that there is no significant transmission of the coronavirus SARSCov2 in asymptomatic people?
- 20. Why are countless politicians seen at various meetings over the last 18 months without masks and without observing the rules of distance? Do they know more than we do about the pandemic or is the pandemic not so dangerous after all?
- 21. What findings have emerged after 18 months of Corona measures that have justified the fact that to date more than 100,000 businesses in Germany have had to cease trading and their employees have lost their jobs?

- 22. Against the background of these figures, how can Mr Söder claim that Germany has come through the Corona crisis in good shape?
- 23. Why have new criteria always been used since the beginning of the pandemic to justify ever more drastic measures (number of test positives, number of people who died with corona, R-value, incidences, intensive care bed capacity, proportion of vaccinated people)?
- 24. Why is it tolerated that tens of thousands of people for the most part without masks and distances take part in the "Christopher Street Day" (CSD), but any demonstration critical of the government measures is banned on the grounds of non-compliance with hygiene measures?
- 25. Why are doctors who have issued medically justified mask exemption certificates having their practices and homes searched by the police?
- 26. Why do four healthy African heads of state die within a short period of time, who have clearly taken a position critical to negative of Corona?
- 27. Why are more than 45 scientific studies ignored that show that mouth-nose coverings are not effective in protecting against disease, and are even dangerous?
- 28. Why has the federal government never made it known what criteria must be met to lift the epidemic situation and for all Corona measures to be lifted and for a free normal life to be possible again for all the people of this country?
- 29. Why have the dire fears of the dissenters (mask compulsion, lockdowns, restrictions up to indirect compulsory vaccination) all come true, although this was vehemently denied by all politicians at the beginning?
- 30. Why are fundamental rights made subject to conditions and are they then still fundamental rights at all?
- 31. Why have thousands of doctors, lawyers, judges, professors ... who hold a different opinion been severely suppressed, slandered, denounced, persecuted, their homes searched and muzzled since the beginning of the "pandemic"?
- 32. With all the ever more stringent measures, are we not increasingly losing sight of what should actually be at stake here, namely the evidence-based assessment of the danger of a virus?
- 33. Why has the scientific community been aligned along political lines for the past 18 months and why has the necessary broad scientific debate been suppressed?
- 34. Why has there never been any European or global coordination of policies, when this is a global pandemic?

MEDIA

35. Why has there been no detailed media coverage of the actual background to the many deaths in Bergamo to date?
36. Why were fear-mongering images deliberately used in the media?
37. If the views of the dissenters are so far-fetched, why has there never been an open and factual round of discussion in which the public would have had the opportunity to perceive the arguments of both sides and evaluate them for themselves?
38. Why was the number of demonstrators against the Corona measures deliberately stated in the media to be many times lower than was demonstrably the case on the basis of video documentation?
39. Why are dissenters put in a right-wing corner as Nazis?
40. Why are high-level experts not given the opportunity to express their concerns to the public?
41. Why is there hardly any or only very selective reporting in the media about developments in other countries?
42. Why are we in Germany deprived of more than five very effective therapies against Covid19 and not informed about them?
43. Why isn't it reported that the vaccines don't begin to deliver what they promised?
44. Why is it that, from the point of view of the media, there is only one disease that is reported on daily, although many more people die from a multitude of other diseases?
45. Why is neither the suicide rate nor the psychosocial consequences of the measures reported in detail?
46. Why have thousands of posts been censored on YouTube and facebook since the pandemic began?
47. Why are we not informed on a daily basis about the numbers of serious side effects and deaths caused by the C vaccination, in addition to the figures on incidence and corona-related deaths?
48. Why are the dangers of corona vaccination not explained in detail on the basis of the data now available?
49. Why are numbers deliberately misleading and scaremongering?
(The most recent example is the proportion of unvaccinated people in intensive care units with more than 90%. However, it is not mentioned that the RKI only counts VACCINATED persons as VACCINATED persons if they also show a Corona-typical "clinical symptomatology"! Otherwise all the vaccinated are counted as unvaccinated. If the real vaccination status would be evaluated for all hospitalized persons, it becomes obvious that the proportion of vaccinated persons is predominant).
50. Why is it not reported that millions of people worldwide are now taking to

the streets and demonstrating against the Corona narrative?

HOSPITAL

- 51. Why are thousands of intensive care beds still being cut and hospitals closed in Germany, even though we are supposedly living in one of the worst pandemics of all time and a major wave of hospitalization is expected?
- 52. Why, of the reported 91,000 or so Corona deaths, were only about 31,000 treated in hospitals in intensive care? What kind of disease is this if 60,000 people did not die in intensive care, even though we believe that in the last stage, ventilatory support is urgently needed?
- 53. Why is it not reported in detail that, according to the latest findings, only about 5 20 % of those who died "with" corona actually died "of" corona, and thus in Germany a maximum of 18,000 people died of corona (similar to the lethality of a medium wave of influenza)?
- 54. Why is it being concealed that the majority of Covid patients requiring inpatient treatment are currently vaccinated?

CORONA VACCINATION

- 55. How could it be that four Covid19 vaccines came on the market almost simultaneously within a few months, although vaccine developments normally take more than 10 years?
- 56. Why is the pressure on unvaccinated people increased so much, when the C-vaccination (of all four manufacturers) does not promise sterile immunity, i.e. herd immunity cannot be achieved by vaccination?
- 57. Why does the media not or only insufficiently report on the multiple and severe side effects of the C vaccination and the many deaths?
- 58. Why don't the manufacturers of the C vaccines have to be liable for side effects and deaths?
- 59. Why does no one complain about the blatantly illegal behaviour by disregarding the Heilmittelwerbegesetz with all the vaccination propaganda and Vaccination advertising campaigns (e.g. necessity of the risk notice: "For risks and side effects, ask your doctor and pharmacist", etc.)?
- 60. Why do about 3% of the batches of corona vaccines result in about 90% of the adverse events and deaths?
- 61. Why have four vaccines received emergency approval in the EU in a very short time, even though they do not protect against the disease?
- 62. Why are autopsies not ordered ex officio for deaths shortly after vaccination?
- 63. Why are vaccination deaths only recognized as such when the vaccination was at least 14 days ago?
- 64. Why is the medical principle, "Never vaccinate into a pandemic!" completely disregarded?

- 65. Why are no investigations carried out to determine the extent to which natural herd immunity to SarsCoV2 has already occurred, and to what extent vaccination might even be contraindicated?
- 66. Why put children, adolescents and young adults at significant risk by urging them to get C vaccine when it is well known that they do not get severe covid when infected with coronavirus?
- 67. Why is the term "corona vaccination" used in common parlance, even though it is demonstrably a genetically manipulative medication and not a vaccination on the basis of the ingredients?
- 68. Why is it legitimate to be afraid of Covid but not afraid of vaccination?
- 69. Why aren't the multitude of studies published that show vaccinated people become superspreaders?
- 70. How can Mr. Lauterbach speak of a Corona vaccination free of side effects when the official EMA figures show more than 13,000 vaccination deaths and more than 850,000 cases with side effects, 245,000 of them serious side effects?

(These are only the reported cases. The number of unreported side effects and deaths due to the Corona vaccinations is assumed to be 5 to 10 times higher. This means that currently up to 130,000 vaccination deaths and around 8 million cases of vaccination side effects can be assumed).

- 71. Why do doctors receive a horrendous hourly rate of 150 EUR or more for one hour of Corona vaccination? Should vaccination incentives be deliberately set here?
- 72. How is it possible that thousands of vaccinated people are contracting Covid19?
- 73. Why do CoV-19 vaccines contain graphene oxide and why is it not reported?
- 74. If vaccination protects so well, why do vaccinated people still have to wear masks and keep their distance?
- 75. Are all vaccinated persons aware that they are taking part in a globally rolledout real world study as a test person, since all four vaccines currently approved in Europe only conditionally (according to the EMA Assessment Report on the conditional approval) are in a STUDY PHASE which is still to be finalised?
- 76. How can it be that there is such incredible political pressure for vaccination, although it is now known that vaccination only promises a milder course of Covid19, but is not capable of doing anything more?
- 77. For every little thing, children need the written consent of their parents in everyday school life. Against this background, does it not seem more than strange that suddenly no parental consent is required for a medical intervention because that is what a vaccination is?

- 78. Last year, the four vaccines were off to a surprisingly fast start. But how come nothing new has happened since then? No further approved vaccine, no effective therapy for infected people, no improved testing possibilities - simply stagnation. Why?
- 79. Why is it that countries with high vaccination rates do not show a decrease in hospitalisation and mortality rates?

FUTURE

- A) How would you feel if you had to find out in a few months that Corona was not really a serious pandemic, but that the vaccination had serious health consequences and that a bad game was played worldwide, just because you too blindly trusted politics and the media?
- B) How would you feel if, in a few months' time, you had to admit that you had not informed yourself comprehensively from the beginning and had not questioned things yourself, and that you had thus made yourself complicit in the inconceivable suffering of the last few months?

RESUME

If you ask yourself all these questions honestly and without bias, you will come to the conclusion: The cogs don't fit together. If the health and safety of people had been at stake from the beginning of the so-called pandemic, then many decisions would have been taken differently.

It is also clear that the mainstream media have followed political pressure and have long since ceased to report independently and without bias.

Question yourself and also take note of other studies, expert opinions and alternative media in order to form your own comprehensive and broad picture of the real situation.
